Dear Mr. Heath:

Recently during a local child care director's meeting, a question arose concerning the proper sink to use to wash children's hands in after diapering. I suggested using the diaper station hand sink since it is usually the closest sink and according to the sanitation rules this sink is to be used exclusively for diaper changing. The child care licensing consultant, Ms. Bee Mayo felt the caregiver should take the child to a hand sink other than the diapering hand sink such as a classroom hand sink or bathroom hand sink. The child care licensing consultants are now using an Infant/Toddler Environment Rating Scale and are evaluating the diapering process and addressing this issue. The sanitation rules do not directly address the issue of which hand sink is appropriate.

In the interest of infection control and consistency between agencies please advise as to which sink would be most appropriate and would meet the intent of the sanitation rules.

SUBJECT: Handwashing of Children After Diapering

This response is to your letter dated October 18, 1999 in which you ask about handwashing of children that have just been diapered. Specifically, you ask in which lavatory the child's hands should be washed.

The child care sanitation rules are not specific on this point; however, there are two areas in the rules that would indicate that the diaper changing area lavatory is appropriate for washing children's hands. The first is 15 NCAC 18A .2819 (j), which states that "Children's hands shall be washed in the lavatory after each individual diaper change ...". The second is found in .2815 (e), which states that "hot water to those areas accessible to children, including lavatories serving diaper changing areas, shall be no less than 90° F (32° C) and shall not exceed 110° F (43° C) ...".

Although the diaper changing lavatory does receive contamination from fecal organisms, the same is true for other lavatories in the bathrooms. In addition, children who are in diapers will typically have their hands washed by a caregiver. This should increase the effectiveness of the washing. Moreover, these lavatories should be cleaned and sanitized several times each day.
